New Electric Rates Took Effect November 1, 2017

On November 1, 2017, an electric rate adjustment took effect for all Canby Utility electric customers. The Canby Utility Board approved the proposed increase in electric rates for all customers following the public hearing held at the regular board meeting on Tuesday, October 10, 2017. After close of the public hearing, the board voted to approve the proposed rate increase.

Customers will see an increase of approximately two percent. Residential customers who have an electric bill for 1,000 kilowatt-hours of usage, the previous bill of \$78.67 will increase to \$80.27, an increase of \$1.60. The board adjusted only the energy charge component and left the fixed residential meter charge unchanged to benefit bill-paying customers. If customers can cut back on electric usage a little, conservation will offset the impact of the rate adjustment.

Commercial and industrial customers that received a bill for 5,000 kilowatthours will see their bill go from \$257.81 to \$261.61, an increase of \$3.80.

The Bonneville Power Administration's recent 2.5 percent increase in wholesale power and transmission costs, effective October 1, 2017, was the largest driver of the need for Canby Utility to adjust its rates. The balance of the rate increase after covering the increased wholesale power costs will go toward increases in local operating expenses, expenses of which were not covered in the last electric rate increase in 2015.

Wintertime Tips

- Caulk around all pipes where they enter the home. Check dryer vents, electrical wiring, water meters and places where heat might leak out or cold air can get in.
- Make sure crawl space openings are closed. This will reduce the amount of cold air getting under your home. This protects exposed pipes and eliminates a significant source of heat loss.
- Fully drain in-ground sprinkler system lines.



Power Outage Checklist: What to have on hand

Most power outages only last a short time. In the event of an extended outage, safety may be of concern. Whatever the duration, it is recommended to prepare and have the right items on hand.

- · Flashlights, extra batteries, candles, and matches
- · Battery powered radios and clocks
- · Corded telephone that can be plugged directly into the wall outlet (cordless/wireless phones require power)
- Canned, dehydrated or freeze dried food, a manual can opener, and plenty of drinking water
- · First Aid kit

Additional steps to consider: Use uninterruptable or a backup power supply for medical equipment or computers; stock adequate fuel for fireplace or wood stove; have a standby generator; know how to operate your garage door manually; have a plan for medications that require refrigeration; ; keep refrigerators and freezers closed as much as possible; and have an alternate charging system for cell phones.
